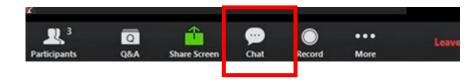

# **Canada's Black population**



- 3<sup>rd</sup> largest "visible minority"
- 8% of Torontonians
- NOT "African Americans"
- 43% Canadian-born
  - •8.9% are third generation or more

# Race-based data & Covid-19

• Year In Review report by Statistics Canada, "**Black people in particular have been far more likely to succumb to the virus than members of other groups.**"

• Communities with racialized women have higher COVID-19 death rates than communities with predominantly white women


• According to a report by the Public Health Agency of Canada, vaccine hesitancy is highest amongst the Black population with **only 34% of Black Canadians stating they would be willing to take the COVID-19 vaccine in November 2020** 

# **Anti-Black Racism**

"Prejudice, attitudes, beliefs, stereotyping and **discrimination** that is directed at people of African descent and is rooted in their unique history and experience of enslavement. Anti-Black racism is deeply entrenched in Canadian institutions, policies and practices, such that anti-Black racism is either functionally normalized or rendered invisible to the larger white society. Anti-Black racism is manifested in the legacy of the current social, economic, and political marginalization of African Canadians in **society**..." (Ontario Anti-Racism Directorate)

# Impacts in primary care - distrust

- Provider biases
  - Provider: Assumptions, microaggressions
  - Patient "resistance" to follow-up, treatment, your care

- Lack of awareness by provider
  - Lack of understanding of patient's journey challenges can lead to invalidation, denial/minimization of experience, victim blaming
  - Patient not feeling safe to share information that impacts their health & wellbeing

Anti-Black racism in healthcare leads to distrust of providers and the system

- Anonymous online survey of Black physicians and trainees in Ontario
- Administered through the BPAO listserv
- Survey data received was analyzed and key themes described
- 46 participants





# **Network of Black Vaccinators**


Establishing a network of Black vaccinators:

• In partnership with hospitals, Black community organizations, and local public health units, the BPAO has begun soliciting Black physicians and health professionals to act as vaccinators and educators at vaccine clinics in Black communities across Ontario

• Immunization clinics and mobile clinics in Black communities, starting with the TAIBU Community Health Centre in Scarborough, will launch in April 2021. This will be the initial pilot before provincial roll-out

# Black Canadian Success Case: TAIBU CHC

# Advice for <u>Distrust</u>: Use LEAP discussion approach

**1.Listen** - to patient concerns (unlikely to explicitly mention racism)

**2.Empower** - reassure the patient in a non-judgemental way that it is <u>their choice</u>. Do not be coercive/impatient. Respect self-determination.

**3.Acknowledge** - acknowledge the historical and present day lived <u>experiences that have led to</u> <u>distrust</u> of government/healthcare/research. These are often rooted in systemic racism but there may be other factors contributing to distrust

**4.Provide** - <u>facts</u> (dispel Myths); and/or offer <u>resources</u> (provide general and culturally relevant); and/or <u>administer the vaccine</u> if patient consents



#### When you can get the vaccine

Ontario has a <u>three-phase plan</u> that prioritizes vaccines for those at greatest risk of severe illness and those who care for them. We are currently completing <u>Phase 1</u> of the plan.


